GUN SAFETY RULES

Observe these rules of safe oun handling.


- 1) Always keep the muzzle pointed in a safe direction. Watch muzzle at all times: never point a gun, accidentally or intentionally, at any person or anything you do not intend to shoot.
- 2) Indetify the target before shooting: DO NOT SHOOT AT SOUNDS.
- 3) Always treat any gun as if it is loaded it may be!
- 4) Keep your finger off the trigger while operating the action and at all other times until you are ready to shoot. Keep the safety "on" or in the "safe" position at all times until you are ready to fire the gun. Learn how your gun's safety works, the safety on any gun is a mechanical device and is not intended as a substitute for common sense or safe gun handling.
- 5) Learn how your gun functions and handles. If you do not thoroughly understand the proper use of your gun, seek the advice of someone who is knowledgeable.
- 6) Do not alter or modify and parts of a firearm.
- 7) Store guns unloaded, separate from any ammunition and where children cannot get to them.
- 8) Be sure the barrel is clear of any obstructions before loading. Make it a habit to check the barrel every time before loading.
- 9) Do not use reloaded, remanufactured, or hand loaded ammunition because it may not meet SAMMI or CIP standards and could cause death, serious personal injury, and/or property damage. Only use high quality, commercially manufactured ammunition in the same caliber as your gun. Please note that using sub-standard ammunition will void the warranty.
- 10) Wear protective shooting glasses and adequate ear protection when shooting.
- 11) Never climb or jump over anything such as a tree, fence with a loaded gun. Unload the firearm before crossing any obstacles. DO NOT USE THE GUN TO HANDLE, PUSH, OR PULL ANYTHING.
- 12) DO NOT SHOOT AT A HARD SURFACE OR AT WATER. Bullet and shot can ricochet or bounce off and travel in unpredictable directions with great velocity.
- 13) NEVER TRANSPORT A LOADED GUN. Do not place a loaded gun into a vehicle. The gun shold be unloaded and placed into a case when not in use.
- 14) NEVER DRINK ALCOHOLIC BEVERAGES BEFORE OR DURING SHOOTING.

LOADING THE MAGAZINE

To load the magazine, press the rim of the 22 LR cartridge by pushing with your thumb into the cartridge throat until the cartridge meets the end of the magazine wall, then keep this process until it reaches to max capacity or less according to your demand.







ADJUSTABLE CHEEK PIECE AND REAR SIDE

To adjust the cheek piece: It can be easily lifted upward or downward. When it is adjusted, use your no.1,5 (included in the box) allen key to tighten the screw. (Picture A)

The front sight can be easily raised or reduced by using no.1,5 allen key (Picture B)





TO INSERT AND FIRE WITH MAGAZINE

Keep the muzzle pointed in a safe direction. Insert magazine into the rifle, as shown with the pictures 4-5-6.







To load a cartridge into the chamber, pull the cocking handle fully rearward and then release the cocking handle.





The rifle is loaded now. The safety should remain ON, if the rifle is not to be fired at that moment. (pictures 9-10) When the safety is in OFF position, the rifle will fire each time when you pull the trigger until the one in the chamber and the ones in the magazine have been fired. Since this rifle is semi-auto, firing will automatically reload and recock the rifle.

After firing, if the rifle is still loaded and not to be fired at that moment, put the safety ON and not to forget pointing in a safe direction. When firing is done, the safety should be moved to ON position and should be remained in ON position at all times.

TO UNLOAD

Point the rifle in a safe direction at all times and keep your fingers away from the trigger. Move the safety to ON position.

Remove the magazine. Pull the cocking handle rearward to eject the chambered cartridge. Hold the cocking handle rearward to verify the rifle is unloaded by visually and physically inspecting the chamber. Unload the magazine in reverse order of loading until the magazine is empty.










DISASSEMBLY

Point the rifle in a safe direction, remove the magazine, pull and hold the cocking handle rearward and make sure there is no cartridge in the chamber by checking both physically and visually and release the handle.


Use no.3 and no.4 (included in the box) allen keys to loosen the main stock screws (Picture 13)

To remove the barrel from the mechanism, use no.2 allen key to loosen the screw. (Picture 15-16).

To remove the trigger group, use no.3 allen key to loosen the no.3 screw inside the trigger group.









REASSEMBLY

Insert the trigger group into the place and tighten the no.3 screw by uysing no.3 allen key. Combine the barrel and stock by pushing the magazine release latch forward by using any thin and long tool when placing the barrel and mechanism. (Pictures 19-20)









MAINTENANCE

Always practice proper gun safety rules and unload the rifle completely.

Disassemble the rifle as shown (Photo 17-18-19-20)

Use a clean rag with lubricant.

To clean inside of the barrel, use a cleaning rod.

Clean the outside of the barrel with a clean rag if necessary.

Lightly coat the outside of the barrel.

Use a soft clean rag to clean the inside of the rifle and the trigger set. (Picture 22)






AMBIDEXTROUS COCKING HANDLE

Tristar agrees to service its products free of charge for defects in materials and workmanship in accordance with the service agreement listed below. The obligation of Tristar under this agreement is limited to the repair or replacement of unserviceable parts and does not cover any incidental or consequential damages. Other than the express warranty contained herein Tristar makes no warranties, express or implied.

Tristar will repair or replace any unserviceable part(s) for one (1) year from date of purchase and further will supply free parts (Wood not included) for an additional four (4) years in accordance with the above warranty statement provided your firearm had not been altered, abused, willfully damaged, or damaged by overpressure ammunition. This agreement is not transferable; its benefits apply only to the original purchaser.

To obtain free service during the time this agreement is in effect, make sure your firearm is unloaded, and send it to Tristar

This agreement and the warranties contained herein are void if your registration card is not received with a copy of your sales slip within 30 days from date of purchase



SHIPPING

When returning your gun for service, please take care in packing. Disassemble your gun, wrap in paper or other protective media and place gun in the original box. (THIS BOX WILL PROTECT THE GUN BUT IS NOT DESIGNED FOR SHIPPING). Wrap box in a cardboard box approved for interstate shipping. Tristar is not responsible for damage incurred during shipping.

STATE REQUIRED SAFETY WARNINGS

Certain states have a law requiring that specific warnings be provided with handguns sold in those states. Because TRISTAR pistols are sold in all states, the safety warnings required by all states are included in this manual

California:
